PFAS

EPA 537.1 and EPA 533 are two distinct methods for the analysis of PFAS in drinking water. The analyses are conducted on differing instrumentation, with calibrations, extraction solvents and sample preservatives being dissimilar among the two methods. Therefore it is probable and not unexpected to see the methods having slight variations in analytical results: Ka'amilo Wells P1 (331-031-WL008) (380-229221-1). (XWB4)

No additional analytical or quality issues were noted, other than those described above or in the Definitions/ Glossary page.
